Also you will need to sign in at the front desk. If you park across the street at the Mall, you will enter the building on the "UG" Level and sign in from there also. The Meeting will be in conference room #275. You will need to be accompanied by staff personnel to the conference room. Please wait to be escorted.

We encourage participation through this format for questions or discussions on items that are brought up from the agenda. These meetings are an opportunity to receive Department and Beacon updates and to share in the discussion of agenda items.
