Registration is required, whether participating in person or online in order for an individual to obtain one Type-2 CEU. *Participation requirements*: This CEU is offered as a FREE event through Beacon Health Options. The CEU requirements for this event remain within the standards and expectations as outlined through the BACB for both in-person and online participants. The Webex platform will measure the amount of time that remote participants attend the CEU event. This means that if you do not attend in-person, you will be required to attend to the Webex screen through the entirety of the presentation with a minimum of 80% attendance. In order to receive credit for attendance online, you should leave the Webex screen open, avoid clicking out of the Webex to complete other tasks, and avoid letting your screen go to sleep. Any of these will negatively impact your attendance rating while participating via the online Webex. Once the Webex has ended, you will be required to submit the verification code via email to:

Those who fail to attend a minimum of 80% via Webex and/or do not submit the verification code and/or survey within 24 hours will be deemed ineligible for the FREE CEU.
