# News and Reminders

#### 1. Claim Submission Reminder

Starting **December 22, 2024**, providers must submit electronic and paper claims to Carelon for processing, even if services rendered occurred under the Optum contract.

- Claims received by Optum after December 21 through December 31, 2024, will be denied and must be resubmitted to Carelon.
- 2. Providers are reminded to ensure that their information is up-to-date in <u>ePREP</u>. Optum and Carelon will use the details saved in ePREP for sending important communications and checks.

# Behavioral Health ASO Transition Information

The Maryland Medicaid Behavioral Health Administrative Services Organization will transition to Carelon on January 1, 2025. Information regarding the transition is posted to this webpage and updates will also be posted here on the Provider Bulletin.
