- 2. The Outpatient Discharge/End Date Change Request Form was removed from the Incedo Provider Portal (IPP) on January 31, 2023. As of this date, providers must use the authorization end-dating functionality in the IPP for ALL authorizations, as detailed in this alert dated January 26, 2023.
  - Please note: Authorizations that have already been end-dated, or are no longer open, cannot have the end-date updated. End-dates can only be edited on active authorizations.
- 3. Residential Rehabilitation Authorizations:
  - Providers are reminded that residential authorizations should be closed before another is opened.
  - When overlapping residential authorizations occur, Optum will close the earlier authorization.
- 4. During the week of January 15, Optum Maryland delivered information to a number of providers regarding missing claim images. Not all providers will have received this communication, but please check your Download folder for a file-name beginning with your provider ID and name, and ending "claims.xlsx."
