Correction: How to Increase COVID-19 Vaccination Acceptance Rates

Target Audience: All organizations interested in administering COVID-19 vaccinations

This alert was originally sent on May 24, 2021. Please refer to this copy which contains corrected information.

Thank you to all of the providers who have either become COVID-19 **vaccinators through ImmuNet**, have **hosted vaccine clinics by partnering with pharmacies or a mobile clinic**, or are working with BHA for **vaccinations at their residential or congregate living facility sites**. These efforts for making vaccinations a one-stop process, located where someone is already receiving care from a trusted source, are critical for getting more of those we serve vaccinated. Vaccination rates for individuals with behavioral health diagnoses are currently lagging far behind the general population. The Maryland Department of Health's Behavioral Health Administration (BHA) will be tracking vaccination rates of the population using the Public Behavioral Health System, and this alert includes methods providers can use to increase their vaccination acceptance rates.

1. ImmuNet:

To register to become a vaccinator, find the ImmuNet Quick Reference Guides at: https://phpa.health.maryland.gov/OIDEOR/IMMUN/Pages/quick_ref_guides.asp. Email questions about the program to mdh.mdimmunet@maryland.gov or call 410-767-6606 Monday-Friday 8am to 5pm. Families and staff are also eligible for vaccination.

Providers can submit claims for COVID-19 vaccine administration. While the federal government provides the vaccine itself for free, providers can submit claims for their administration of COVID-19 vaccines.

Providers who are paneled with an MCO must bill the patient's MCO for vaccine administration, or, if not paneled with an MCO, medical practitioners would bill through eMedicaid for Medicaid recipients. However, in Maryland, behavioral health providers

are “carved out” and directed to bill the ASO. This alert pertains to these providers who bill through the ASO, Optum, Maryland.

COVID-19 vaccines should be administered as soon as providers become eligible and receive supplies. Depending on the provider type listed below, claims may be submitted immediately or may need to be held until setup is complete.

No authorization is required. All claims for administration of the vaccine should be submitted using only one ICD-10-CM code: **Z23, Encounter for immunization**, with any place of service (POS). The service will only be billable on the CMS 1500 or 837P. Claims will be payable under both Medicaid and Uninsured.

Presently, the following Behavioral Health Providers with the following category of services can be paid - PT 15, 24, 27, 32, 50, 54, CC, 94, MT and MC. Providers will be alerted when Provider Type PR has been added to the eligible provider types.
