News and Reminders

1. Optum Maryland office and call center will be closed on November 28 and 29, 2024, in observance of the Thanksgiving and Native American Heritage holidays. Provider payments for the week of November 24 will be made one day early on Wednesday, November 27.

2. Claim Lifecycle Report

The October 2024 Claim Lifecycle Report contained an error in reported October balances. No errors have been found in the claims detail on the report.

- The balance errors are corrected on the November reports; however, Optum will
 re-run the November reports because the off-setting notice on tab 2, column H is
 incorrect.
 - The off-setting corrections do not affect balance information or claims detail.
- The revised November reports are scheduled to be available early the week of December 2, 2024.
- Please work with your Reconciliation Manager if you have further questions.
