- 1. Effective October 1, 2022, all Behavioral Technicians (BT) enrolling to render ABA services to Medicaid participants must follow the updated instructions below when submitting their application in the electronic Provider Revalidation and Enrollment Portal (ePREP). - 2. On Tuesday, October 18, MDH communicated to providers that the Estimated Payments Forgiveness Program of up to \$25k would be reopened. Please view the provider alert dated <a href="October 18">October 18</a> for full details.
- 3. The check-write for claims submitted this week (week of October 16) will occur one day early, on the morning of Saturday, October 22. Please see this provider alert for details.
- 4. The Incedo Provider Portal will be unavailable from 5 a.m. 11:59 p.m. EDT on Saturday, October 22 while a system upgrade is implemented. Please see

- 5. Providers who completed the Estimated Payment Repayment survey and selected to repay (either fully or partially) using ACH received an <u>ACH form</u> and cover letter by email on October 18. Please complete and return this form to maryland.provpymt@optum.com by **October 24, 2022.**
